### Assumptions Used in Arriving at Fiscal Estimate

This bill does all of the following:

1. Current law provides that an agency that is authorized to exercise discretion in deciding individual cases may formalize the general policies evolving from its decisions by promulgating those policies as rules. The bill requires an agency to promulgate rules describing how and when the agency will impose conditions on a license, permit, certificate, or other such approval that is granted by the agency. The agency must, under the bill, impose conditions on licenses in accordance with those rules.
2. Current law allows the governor, by executive order, to prescribe guidelines to ensure that rules are promulgated in accordance with the statutory rule-making process. The bill repeals this provision that allows the governor to prescribe such guidelines.

Local:

No fiscal effect.

State:

In accordance with current law, the Department of Public Instruction (DPI) does not impose any standard, requirement, or threshold on any license it issues other than those standards, requirements, or thresholds that are explicitly required or permitted by statute or rule. Under the bill, in cases where the DPI is required or permitted to impose conditions on a license, the DPI will be required to promulgate rules describing how and when it will impose conditions on a license it grants and impose conditions on licenses in accordance with those rules.

The DPI's Administrative Rules Coordinator works with DPI program staff to promulgate administrative rules, with support from the DPI Office of Legal Services. Rules are drafted in accordance with changes in statutes and/or agency policy. It takes a significant amount of staff hours to promulgate a rule, depending on the type of rule and subject matter, in accordance with the statutorily prescribed process, which currently takes about a year to complete. The changes described in the bill may result in increased staff time focused on rulemaking and enforcing compliance with DPI rules, though the amount of additional time required to meet the bill's requirements is unknown. Therefore, the net fiscal impact to the state is indeterminate.

The bill's repeal of provisions that would allow the governor to prescribe such guidelines to ensure that rules are promulgated in accordance with the statutory rule-making process do not directly impact the DPI, so the DPI is not in a position to estimate the impact of these changes.
