**Assumptions Used in Arriving at Fiscal Estimate**

The proposed legislation creates an application fee exemption for veterans and members of the U.S. armed forces who apply for admission to University of Wisconsin System (UWS) institutions or a Wisconsin Technical College System (WTCS) district.

**Long-Range Fiscal Implications**

In Fiscal Year 2020, nearly 3,000 students self-identified as newly enrolled veteran students and had never attended a WTCS district. The districts currently charge a \$30 application fee. Under this legislation, the WTCS districts would have seen a loss of nearly \$90,000 in fiscal year 2020.
