Assumptions Used in Arriving at Fiscal Estimate

The bill would provide for a semester of undergraduate tuition remission to resident undergraduate students enrolled in a teaching program during the student's semester of student teaching. The bill would create a sum sufficient appropriation at the UW System to reimburse the UW System for the remissions.

The bill would first apply to individuals who commence student teaching in the first semester that begins after the effective date of the bill. The bill would take effect on the first day of the third month beginning after publication.

Long-Range Fiscal Implications

The UW System estimates a tuition only amount for 4,160 resident student teachers of \$14 million annually.
