**Assumptions Used in Arriving at Fiscal Estimate**

The Department of Transportation does not expect this proposal to create a cost impact in the production and distribution of the state maps.

This is because the Department already has a process in place to track and manage map requests for legislative offices. This process may need to adjust slightly under the proposed legislation, but no major changes or additional staffing needs would be expected. In addition, the Department places a standard printing order of 1,000,000 folded maps, 7,200 flat laminated maps, and 8,000 flat unlaminated maps each biennium to secure a printing-volume discount. This proposal would not impact that standard order, any reduction in maps requested by legislative offices would increase the number of maps available to the public at rest areas, welcome centers, and other public locations, thereby not impacting the overall quantity ordered.
