Assumptions Used in Arriving at Fiscal Estimate

This bill requires the UW System to ensure no designated foreign mission of China is established at or recognized by a UW institution; annually identify the amount and source of funding received from a designated foreign mission of China; identify and end any "cultural exchange" programs that are consistent with those identified by the U.S. State Department as Chinese Communist Party propaganda tools; prohibit employees and students from participation in Communist Chinese recruitment programs; and requires reporting.

Long-Range Fiscal Implications

This bill would increase costs for the UW-System. Until the programmatic requirements are determined it is difficult to quantify an amount for a fiscal estimate. The cost would however be significant enough that it couldn't be absorbed in the current budget.
