Assumptions Used in Arriving at Fiscal Estimate

2021 Senate Bill 866 (SB-866) would enumerate a project to construct additional columbarium space at the Southern Wisconsin Veterans Memorial Cemetery in the village of Union Grove under the 2021-23 Authorized State Building Program of 2021 Wisconsin Act 58. The project would be under the purview of the Department of Veterans Affairs (DVA) and would be financed with \$5,000,000; \$440,000 of which would be program revenue (PR) and the remaining \$4,560,000 would be federal funds (PR-F) received from the U.S. Department of Veterans Affairs.

This project enumerated by SB-866 corresponds to Phase VI of the Southern Wisconsin Veterans Memorial Cemetery project. Federal funds in the amount of \$4,560,000 were awarded for this phase via the Veterans Cemetery Grant program of the U.S. Department of Veterans Affairs and will expire prior to the adoption of the 2023-2025 State Building Program. The \$440,000 PR of the total \$5,000,000 for the project would be derived from cash sources from appropriation accounts under DVA.

If enumerated as a capital project, planning would continue through fall of 2022 with the goal of starting construction in January 2023 to be completed in January 2024. There is no anticipated fiscal impact upon the Department of Administration's operations. Any related Division of Facilities Development (DFD) personnel time and expenditures associated with this enumeration would be absorbed by existing staff and expenditure authority under s. 20.505 (1) (kc), Wis. Stats., Capital planning and building construction services (numeric 13500).
