The Department of Corrections requests reallocating \$21,098,058 in bonding authority awarded under the Juvenile Corrections Grant Program pursuant to the Committee's approval of the modified Juvenile Corrections Grant Committee's statewide juvenile justice plan on February 12, 2020, under 2017 Wisconsin Act 185, section 110(4)(f), as amended by 2019 Wisconsin Act 8, section 66. The reallocation would increase the awards for Racine County by \$7,975,000 and Milwaukee County by \$13,123,058, and deobligate \$21,098,058 from the awards previously approved for Brown and Dane counties.
