### Assumptions Used in Arriving at Fiscal Estimate

This bill recognizes same-sex marriage by making references in the statutes to spouses gender-neutral, with the intent of harmonizing the Wisconsin Statutes with the holding of the U.S. Supreme Court in Obergefell v. Hodges, 135 S. Ct. 2584, 192 L. Ed. 2d 609 (2015), which recognizes that same-sex couples have a fundamental constitutional right to marriage.

The bill would require the Vital Records Office, within the Department of Health Services (DHS), to update forms and other materials, modify its information system, and communicate with partners. Initial implementation activities can be accomplished with existing staff. However, ongoing system maintenance tasks, in addition to reviewing requests and answering questions from the public and business, would require authority for 1.0 PR FTE position (Records Program Associate Advanced), for a cost of \$69,500 PR annually.

### Long-Range Fiscal Implications
