Assumptions Used in Arriving at Fiscal Estimate

This bill authorizes physical therapists to confirm to the Department that a person is eligible to acquire a disabled parking plate or card. This bill will have no annual fiscal effect on the Department of Transportation. It will create no new annual expenditures or revenues.

There will be one-time costs of \$1,700 for an IT project to update the Department's systems to adopt these changes. The IT work associated with this effort will require inter-agency coordination between the Department of Transportation and the Department of Safety and Professional Services to define requirements and to test the Department's and third-party vendor IT systems. It is estimated that this will take between 3 to 7 months.

Long-Range Fiscal Implications

This bill will have no annual fiscal effect on the Department of Transportation. It will create no new annual expenditures or revenues.
