Assumptions Used in Arriving at Fiscal Estimate

This bill would prohibit an employee of the state or a local unit of government, when acting within the scope of employment, to perform abortion services or related activities, with certain exceptions. In addition, under the bill, no public property could be used for the same services or activities. Currently, DHS programs and services are governed by s. 20.927 and s. 20.9275, which prohibit the use of state or federal funds for abortion services or related activities, except in certain circumstances. This bill is not expected to increase or decrease expenditures for the Department or local units of government.
