Assumptions Used in Arriving at Fiscal Estimate

The fiscal impact is indeterminate. It is possible that more people enter regulated care as a certified provider which could mean more families using WI Shares, but that is uncertain as the department does not have data that would readily establish how many additional families would use WI Shares. Counties are responsible for certification duties and are given an allocation from DCF on an annual basis. It is not anticipated that changes in this bill would result in an increase to county certification duties

This bill provides no additional funding.
