Assumptions Used in Arriving at Fiscal Estimate

The bill requires the Department of Workforce Development (DWD) to establish and maintain a toll-free telephone number to serve as a hotline, operating during normal business hours, as determined by the department, and staffed by DWD designated personnel, to assist employers seeking to employ individuals with a conviction record. In addition to the toll-free telephone number, DWD is required to maintain a website that contains information relevant to employing people with a conviction record, including those participating in certain work release programs. The bill requires DWD to provide information and assistance relating to available incentives and programs under state and federal law for employing individuals with a criminal record, including individuals participating in certain work release programs.

If enacted, the department estimates the ongoing, annual costs to perform activities, such as being available during normal business hours to answer routine and complex questions, keeping current on incentives and programs related to the hotline's subject area, and coordinating with the Wisconsin Department of Corrections and other relevant agencies, would be \$115,000, which is the cost of contracting for 1.0 FTE Program and Policy Analyst – Advanced position. These new, specialized activities are not absorbable within the department's existing operations. The bill does not provide position authority, therefore DWD would need to contract for the designated staffing requirements of this bill.

Ongoing costs to establish a toll-free telephone number for the hotline as well as a department website for the hotline telephone number, hours of operation, and basic assistance information for employers seeking to hire individuals with a conviction record, are estimated to be minor and absorbable within agency operations.
