Assumptions Used in Arriving at Fiscal Estimate

Under current law, an individual who holds any provisional teaching license is eligible for a tier III lifetime license upon successfully completing six semesters of teaching experience. This bill provides an option for a federally recognized American Indian tribe or band to decide whether each applicant for a lifetime license to teach the American Indian language associated with the tribe or band in an American Indian language program is qualified to receive the lifetime license.

Local impact: None.

State impact: Indeterminate

Individuals applying for an educator license must submit an application fee to DPI. This revenue is used to directly support the operations of the educator licensing operations of DPI. The number of license applications is not likely to change much as a result of this bill, but it could have a marginal impact. DPI cannot accurately project what that impact would be, thus, the fiscal impact of this bill on the state (DPI) is indeterminate.
