### Assumptions Used in Arriving at Fiscal Estimate

There is no fiscal effect if the Wisconsin Elections Commission (WEC) is not otherwise required to obtain the information currently provided through ERIC- if this assumption is correct, then there would not be an additional cost. The following information will no longer be received by the WEC if the proposed legislation becomes law:

- (1) Double Voters. Wisconsin voters who cast a ballot in both Wisconsin and another state in the same federal election.
- (2) Out of State Deaths. Wisconsin voters who died in another state.
- (3) Duplicate Registrations. Wisconsin voters who have another active voter registration under an alias or pseudonym.
- (4) Out of State Movers. Wisconsin voters who moved to another state.
- (5) Eligible Citizens. Wisconsin citizens who are eligible to vote but not registered.
