#### Assumptions Used in Arriving at Fiscal Estimate

This bill increases funding in GPR appropriation s. 20.445 (1)(cr) State supplement to employment opportunity demonstration projects by \$799,400. This legislation increases current funding levels from \$200,600 to \$1,000,000 in each fiscal year of the 2023-25 fiscal biennium.

The bill also requires the department to establish a pilot transitional jobs program that operates during the 2023-25 fiscal biennium and includes a provision to sunset funding on June 30, 2025. The bill creates s. 20.445 (1)(fc) as an annual GPR appropriation and provides \$500,000 each fiscal year of the 2023-25 biennium to fund the program. The bill limits program eligibility to individuals receiving housing vouchers or receiving services from state-funded homeless shelters. The legislation also requires DWD to offer job and employment services like services offered under Transform Milwaukee Jobs and Transitional Jobs programs (s. 49.163). Under the bill, DWD must establish eligibility criteria for individuals participating in the pilot program and may either administer the program itself, or contract with an entity to administer the pilot program that is also authorized to administer the programs under s. 49.163.

This bill creates s. 106.115 to describe that the Governor's Council on Workforce Investment's (CWI) required activities related to submitting the Wisconsin's WIOA State Plan include identification of employment, training, and educational services for three specific populations as defined in title 42 of the United States Code. These populations include: homeless individuals from ages 18 to 24; certain children placed in out-of-home care; and homeless adults.

This bill will increase costs to the department, but these costs can be absorbed within the agency's budget.

The department estimates no fiscal impact and no additional required activities related to the increase in funding provided under s. 20.445 (1)(cr) State supplement to employment opportunity demonstration projects.

Regarding the pilot transitional jobs program, this estimate assumes that the department would contract with the Department of Children and Families (DCF) to implement and administer the program as would be permitted under the bill. For the purposes of this fiscal estimate, the department assumes that it would contract with the Department of Children and Families (DCF) to implement and administer the pilot transitional jobs program. This partnership is permitted under the bill, and it is worth noting that DCF currently manages the Transform Milwaukee Jobs and Transitional Jobs programs. DWD would be able to absorb costs related to establishing eligibility criteria and contracting with DCF to implement and administer the pilot program.

Local fiscal effects resulting from the pilot program outcomes are indeterminate. Assuming the pilot program assists some number of homeless individuals to maintain unsupported local employment, there will likely be reduced local expenditures and increased local revenues by an amount dependent on individuals' length of time of workforce attachment, wage progression, and other factors that are unknown at this time.

Regarding the provision that adds CWI to the list of entities with which the department collaborates with in order to establish and administer federal funds under the Workforce Innovation and Opportunity Act (WIOA), this aligns with current department practice and is not estimated to have a fiscal effect.

The bill's provision that CWI include in the state's WIOA State Plan identification of employment, training, and educational services for three specific populations has no fiscal impact to the department because the information outlined in the bill was already included in Wisconsin's WIOA State Plan that was submitted on March 15, 2022 to the U.S. Department of Labor.

The following Fiscal Estimate Worksheet only includes the annualized cost increase associated with the \$799,400 GPR appropriated to s. 20.445 (1)(cr) and does not include an annualized cost estimate for the one-time funding provided in s. 20.445 (1)(fc) for the purpose of providing services to Wisconsin's homeless population through a transitional jobs pilot program.
