Assumptions Used in Arriving at Fiscal Estimate

The bill changes the Minority Teacher Loan program from minority students being eligible for the program to only economically disadvantaged students being eligible for the program. Students race, ethnicity, national origin, gender, sexual orientation or religion may not be considered to be eligible for this program. Public or private schools must be defined as pupils eligible for free or reduced lunch by at least 80%. Students who received the Minority Teacher Loan are eligible to receive forgiveness by teaching at a school whose minority population is at least 40%.

Minority Undergraduate Grant changes students that are eligible for the program from being a minority student to being an undergraduate disadvantaged student.
