Assumptions Used in Arriving at Fiscal Estimate

The draft bill requires the elections commission to, "inform the person in writing at the time his or her right to vote is restored under this subsection." It is not possible to estimate the costs of this requirement without further information about this requirement. Two issues prevent an analysis.

First, the Wisconsin Elections Commission has no information about whether a person convicted of a felony has fulfilled their sentence as defined in the draft bill. The Wisconsin Elections Commission is not notified when a felon completes their term of imprisonment or probation, or when they have paid all fines, costs, fees, surcharges, and restitution, or when they have completed community service imposed in connection with the crime. Upon information and belief, only the Department of Corrections has this information. Obtaining this information from the Department of Corrections would likely require additional legislation, and the requirements of that legislation would dictate the processes - and therefore costs - associated with obtaining the information.

Second, the Wisconsin Elections Commission has no information about the location and contact information of persons convicted of a felony. The Wisconsin Elections Commission has no information whatsoever about convicted felons who have not previously registered to vote. Felons who were previously registered to vote have had their registrations inactivated - often many years in the past - and the Wisconsin Elections Commission does not track them, or update contact information, after notice of conviction. Upon information and belief, only the Department of Corrections tracks the location and contact information of convicted felons. Obtaining this information from the Department of Corrections would likely require additional legislation, and the requirements of that legislation would dictate the processes - and therefore costs - associated with obtaining the information.

With additional information addressing the two issues above, it will be possible to provide a fiscal estimate.
