### Assumptions Used in Arriving at Fiscal Estimate

This bill creates a \$5,000 surcharge to be imposed on person who are convicted of patronizing or soliciting prostitutes, pandering, or keeping a place of prostitution. The surcharge amounts will be used for treatment and services for sex-trafficking victim, and investigation and law enforces relating to Internet crimes against children.

This surcharge will require staff time for CCAP programming changes. The fiscal effect is indeterminate.
