### Assumptions Used in Arriving at Fiscal Estimate

This bill recognizes same-sex marriage by making statutory references to spouses gender-neutral. As it relates to the Department of Natural Resources, the bill includes updates to several GoWild license products (i.e., fishing and wild rice dealer/harvester licenses) to include "spouses" instead of "husband and wife".

The department would incur minimal costs to make changes to its license products; therefore, the bill has no fiscal impact.
