Assumptions Used in Arriving at Fiscal Estimate

Under the bill, the rules of proceedings for a governing body of a political subdivision may not prohibit the body from taking up an ordinance or resolution that is substantially similar or identical to an earlier ordinance or resolution that was taken up and voted upon but not enacted or adopted if the later ordinance or resolution is taken up at least two years after the earlier.

The bill has no local or state fiscal effect.
