Senate Bill 102 (SB 102) ratifies the contract negotiated between the University of Wisconsin-Madison and the Wisconsin State Building Trades Negotiating Committee for fiscal year (FY) 2024-25. As a separately negotiated contract, there is no impact to State agencies.
