

EXECUTIVE ORDER 70-4

ASSIGNING EMERGENCY PREPAREDNESS RESPONSIBILITIES AND EMERGENCY FUNCTIONS TO THE DEAN OF THE GRADUATE SCHOOL OF BUSINESS OF THE UNIVERSITY OF WISCONSIN

WHEREAS, a permanent condition of preparedness must be achieved by the State to deal with emergency situations of all kinds, including nuclear war; and

WHEREAS, the governments of the United States and of the State of Wisconsin have contracted to develop coordinated plans to this end; and

WHEREAS, the actions necessary to deal with these emergency situations are of direct concern to the agencies of the State government; and

WHEREAS, the maintenance of the effectiveness of a condition of preparedness can best be accomplished through support by selected agencies of the State government;

NOW, THEREFORE, I, WARREN P. KNOWLES, Governor of the State of Wisconsin, by virtue of the authority vested in me by the State Constitution and by the laws of the State of Wisconsin and in accord with the provisions of Chapter 22, Wisconsin Statutes, as enacted by the Legislature in Chapter 526, laws of 1958, do hereby order and direct the assignment of certain emergency functions and responsibilities, over and above those previously assigned, to the Dean of the Graduate School of Business of the University of Wisconsin.

SECTION I. SCOPE

The Dean of the Graduate School of Business of the University of Wisconsin is hereby delegated the authority and responsibility for coordinating and directing all state government functions relating to economic stabilization activities within the state during periods of national emergency provided for in the statutes cited above and shall:

- A. Develop plans and procedures for the efficient and effective guidance and coordination of all economic stabilization activities in the state.
- B. Develop and maintain a state of readiness in economic stabilization activities within the state with respect to all degrees of national emergency including attack upon the United States.
- C. Be prepared to implement all plans developed under this order.
- D. Develop and maintain plans and an operational organization for and render all required administrative and logistical support to the State Economic Stabilization Agency, provided for in Section 4, RM-2, Part A, State Plan for Emergency Management of Resources.

SECTION II. PREPAREDNESS RESPONSIBILITY

The Dean of the Graduate School of Business of the University of Wisconsin shall develop long range programs designed to integrate all economic stabilization activities in the state in a national emergency. In doing so he shall:

- A. Review available federal guidance materials to assure understanding of and compatibility with national aims and especially with provisions of the National Plan for Emergency Preparedness.
- B. Establish liaison and working agreements with appropriate federal agencies.
- C. Assemble, analyze and evaluate data on economic stabilization requirements to meet emergency needs of the people of the state.
- D. Develop plans and procedures for the collection and analysis of information relative to economic stabilization in emergency periods.
- E. With due regard for plans developed by federal agencies assigned economic stabilization responsibilities, be prepared to provide the administrative and logistical support required to perform the functions herein assigned and delegated.

SECTION III. EMERGENCY FUNCTIONS

In the event of national emergency provided for by the Wisconsin statutes cited herein, the Dean of the Graduate School of Business of the University of Wisconsin, making full use of the State Economic Stabilization Agency, shall:

- A. Advise and assist the Governor in directing and coordinating economic stabilization functions in the state in accord with the state plan for emergency management of resources.
- B. Develop policy and guidance for economic stabilization activities in emergency operations with due regard to national aims in this field.
- C. Render all required administrative and logistical support to the State Economic Stabilization Agency.

SECTION IV. FUNCTIONAL GUIDANCE

The Dean of the Graduate School of Business of the University of Wisconsin, in carrying out the functions outlined in this order shall be guided by the State of Wisconsin emergency plans. He shall:

- A. Ascertain requirements for all supporting resources required for carrying out the assigned responsibilities and take such actions as may be required and are within the laws of the state, to insure their availability in national emergencies.
- B. Develop such organization as may be required to perform the assigned functions, subject to the laws of the state.
- C. Provide for continuity of operation through developing lines of succession to key positions, through safeguarding of essential records, maintenance of alternate headquarters and through effective use of government resources, personnel and facilities.

SECTION V. MEMBERSHIP ON THE RESOURCE PRIORITIES BOARD

Notwithstanding the assignments made herein, the Director of the State Economic Stabilization Agency shall represent the economic stabilization functions on the Resource Priorities Board provided for in Section 5, RM-2, Part A, State Plan for Emergency Management of Resources.
