EXECUTIVE ORDER #109

Relating to re-creating non-statutory committees

WHEREAS, Wisconsin Statutes § 14.019, provides that under the general powers of the Executive Office, the governor may create and abolish non-statutory committees by Executive Order; and

WHEREAS, Wisconsin Statutes § 14.019 provides that any non-statutory committee created under that section shall expire on the fourth Monday of January of the year in which a new gubernatorial term of office begins, unless the new governor, by Executive Order, provides for its continued existence; and

WHEREAS, persons now serving on such committees remain members until they resign or until they are removed or replaced by action of the governor;

NOW, THEREFORE, I, TOMMY G. THOMPSON, Governor of the State of Wisconsin, by the authority vested in me by the Constitution and the laws of this State do hereby re-create the following non-statutory entities, effective the fourth Monday of January, 1991:

- Wisconsin Bicentennial Committee on the Constitution
- State Occupational Information Coordinating Council
- Governor's Advisory Council on Judicial Selection
- State Interagency Coordinating Council on Handicapped Children's Programs
- Governor's Commission on Law Enforcement and Crime
- Governor's Juvenile Justice Commission
- State Job Training Coordinating Council
- Governor's Committee for People with Disabilities
- Governor's Science and Technology Council
- Commission for a Quality Workforce
- Governor's Advisory Committee on Recreational Business Development
- State Agency Employee Assistance Program Advisory Committee
- Telecommunications Relay Service Council


