EXECUTIVE ORDER NO. 372

Relating to the Transfer of Two Medical Clinics to the University of Wisconsin Hospitals and Clinics Authority

WHEREAS, the Roley Obstetrics/Gynecology Clinic has been owned for a number of years by the University of Wisconsin Medical Foundation, a nonprofit corporation established to support the missions of the University of Wisconsin-Madison and the UW Medical School; and

WHEREAS, the University Physicians-Middleton Clinic has been owned for a number of years by University Community Clinics, a University and University Hospital and Clinics affiliated nonprofit corporation; and

WHEREAS, during this period, UW Medical School faculty physicians have provided staff and medical direction to these clinics; and

WHEREAS, the University of Wisconsin Hospitals and Clinics Authority (UWHCA) has agreed with the University of Wisconsin Medical Foundation and University Community Clinics to take over operations of these clinics and their programs and convert them to UWHCA based clinics as of July 5, 1999; and

WHEREAS, as part of the programs to be transferred, there is a need for qualified and experienced clinical support staff, including licensed practical nurses, technologists and technicians, and office support staff, including coding, billing, and medical records and secretarial staff, to be employed by the University of Wisconsin Hospitals and Clinics Board (UWHC Board) and for two registered nurses to be employed by UWHCA; and

WHEREAS, there is a shortage of experienced, qualified persons to provide these specialized services; and

WHEREAS, the individuals working in the programs were and will continue to be under the medical direction of University of Wisconsin Medical School faculty members; and

WHEREAS, the transfer of clinical support and office support staff will provide a smooth transition and uninterrupted quality patient care and services;





NOW, THEREFORE, I, TOMMY G. THOMPSON, Governor of the State of Wisconsin, by virtue of the authority vested in me by the Constitution and laws of the State of Wisconsin, and in accordance with Secs. 111.93(3) and 230.15(1m), Wis. Stats., and the contract between the State of Wisconsin and the Wisconsin State Employees Union in Article V, Section 1, do hereby direct that:


All employees of the Roley Obstetrics/Gynecology Clinic and the University Physicians-Middleton Clinic, who the University of Wisconsin Hospitals and Clinics Authority on delegation from the Department of Employment Relations determines are eligible for accretion into the classified service of the State of Wisconsin at the UWHC Board, shall be given seniority and sick leave based on their service with the University of Wisconsin Medical Foundation and with the University Community Clinics, respectively.
