2. Form, Style and Placement in Administrative Code

The analysis to the rule should contain a reference to the statute that authorizes promulgation of the rule and any statute that the rule interprets. [See s. 1.02 (2) (a), Manual.]

5. Clarity, Grammar, Punctuation and Use of Plain Language

- a. In s. ATCP 42.01 (3) (a), what is meant by "significant portion"? Should "significant portion" be replaced with a specific percentage?
- b. In s. ATCP 42.01 (3) (b), how is it to be determined from whom the purchaser has obtained the formula for the commercial feed?
- c. Section ATCP 42.04 (1) (intro.) should clearly state who has the duty to label commercial feed according to the subchapter.
- d. In s. ATCP 42.04 (1) (b), is the manufacturer required to notify the purchaser that he or she may request labeling under subch. III for mill formulated feed?
