Comments

2. Form, Style and Placement in Administrative Code

- a. The narrative portion of the department's analysis fails to discuss the treatment of s. A-E 2.03 (2) (f) by Sec. 6 of the rule.
- b. In s. A-E 2.01, the current "and" that separates "9" and "10" should be included and stricken. In addition, the last sentence of that section should be included.
- c. In s. A-E 2.02 (2), a note should request the Revisor of Statutes to delete the professional geologist registration seal.
 - d. Should the reference to "professional geology" in s. A-E 8.03 (3) (a) be deleted?

3. Conflict With or Duplication of Existing Rules

The Department of Natural Resources (DNR) has a rule that references ch. A-E 10. Since ch. A-E 10 is being repealed and since ch. A-E 8 will not apply to geologists, the board should contact DNR to point out that cross-reference changes will be needed in s. NR 500.05 (4) (b) after the board promulgates this rule.

5. Clarity, Grammar, Punctuation and Use of Plain Language

In the first paragraph of the department's analysis, "repeal and amend" should be replaced by "repeals and amends" in the first and third sentences.
