### CLEARINGHOUSE RULE 11-035

#### Comments

**[NOTE: All citations to “Manual” in the comments below are to the Administrative Rules Procedures Manual, prepared by the Legislative Reference Bureau and the Legislative Council Staff, dated September 2008.]**

#### **2. Form, Style and Placement in Administrative Code**

a. In the introductory clause for the proposed order, “s.” and “ss.” should be removed. In addition, “and” should replace the commas after “2.04 (1) (g) and 7.03 (2)”, and “and” should be added after “(2) (a), (g)”. [s. 1.02 (1), Manual.] As revised, the clause should read as follows: “An order of the dentistry examining board to amend DE 2.03 (1) (b), (5) (a) 2., 2.04 (1) (g) and (h), (2) (a), (g), and (h), 6.02 (4) (c), 7.03 (2) and 7.05 (2) (a); and to create DE 2.03 (1) (c) and (5) (a) 3., relating to CPR...”

b. The SECTION numbers should be corrected. After SECTION 7, the rule text currently begins with a new SECTION 1.

c. Throughout the rule text, the full section number should appear before the first affected provision under any given treatment clause. For example, in SECTION 1, “(b)” should be replaced with “DE 2.03 (1) (b)”. [s. 1.04 (2), Manual.]

d. Section DE 2.03 (1) (a), (b), and (c) should be modified to end in periods rather than semicolons. [s. 1.03 (1) (b), Manual.] In addition, s. DE 2.03 (1) (intro.) should be amended to add the phrase “all of the following” after the word “board.” Although the latter change is proposed in Clearinghouse Rule 11-033, the modification should be made in both proposed rules to ensure consistency in the event that only one of the two rules is promulgated.

e. All subdivisions in s. DE 2.03 (5) (a) should be modified to end with periods rather than semicolons. [s. 1.03 (1) (b), Manual.] In addition, s. DE 2.03 (5) (a) (intro.) should be amended to include the phrase “all of the following” after the word “filing” or after the word “board”.

f. In the SECTION amending provisions of s. DE 2.04, the treatment clause should be revised to read as follows: “DE 2.04 (1) (g) and (h) and (2) (a), (g), and (h) are amended to read:”.

g. A deadline for the submission of comments should be added to the analysis, once it is known. [s. 227.14 (2) (a) 8., Stats.]

#### **5. Clarity, Grammar, Punctuation and Use of Plain Language**

In s. DE 2.03 (5) (a) 3., “Wisconsin” should be added before “department of health services,” to be consistent with other provisions in the rule.
