Clearinghouse Rule 06-031

The Department of Commerce proposes an order to repeal ss. Comm 5.62 (3), Comm 5.625 (4) (c), and Comm 5.72 (5); to renumber and amend ss. Comm 5.51 (6) (c) 1., Comm 5.52 (6) (c) 1., Comm 5.54 (5) (c) 1., Comm 5.91 (8) (b) 1., Comm 5.92 (8) (b) 1., Comm 5.93 (6) (b) 1., and Comm 5.94 (6) (b) 1.; to amend ss. Comm 5.003 (22), Comm 5.02 Table 5.02 lines 22. to 27. and 55. to 66., Comm 5.06 Table 5.06 lines 22. to 27. and 55. to 66., and Comm 5.323 (1); to repeal and recreate s. Comm 5.70 (1); and to create ss. Comm 5.51 (6) (c) 1. b., Comm 5.52 (6) (c) 1. b., Comm 5.54 (5) (c) 1. b., Comm 5.91 (8) (b) 1. b., Comm 5.92 (8) (b) 1. b., Comm 5.93 (6) (b) 1. b., Comm 5.94 (6) (b) 1. b., and Comm 5.97 (7) (c), relating to licenses, certifications and registrations, and affecting small businesses.

Analysis of Proposed Rules

1. Statutes Interpreted.

2. Statutory Authority.

3. Related Statute or Rule.

None.

4. Explanation of Agency Authority.

Chapter 101, Stats., authorizes the Department of Commerce to adopt reasonable and proper rules relative to the exercise of its powers and authorities, including the issuance and renewal of various credentials to businesses and individuals. Chapter 145, Stats., grants the Department authority to promulgate rules governing plumbers and automatic fire sprinkler system installers. 2005 Wisconsin Act 25 contains revisions to the credential terms for plumbers and automatic fire sprinkler system installers.

5. Summary of Proposed Rules.

Chapter Comm 5 of the Wisconsin Administrative Code contains the Department's rules for the issuance and renewal of numerous credentials which businesses and individuals are either mandated or permitted to obtain. These credentials are licenses, certifications and registrations that relate to activities associated with the construction and inspection of buildings and structures or specific components and elements that serve buildings and structures.

The proposed rules consist of revisions in chapter Comm 5 in order to address some administrative issues that have occurred since the last update of chapter Comm 5. The definition of HVAC equipment and an exception for obtaining the HVAC contractor registration are being revised in order to clarify who must obtain the registration. The credential terms for automatic fire sprinkler system installers and plumbers are changed to 4 years. The respective credential fees and any required continuing education hours are adjusted accordingly. The experience requirements for qualifying for the examination for the commercial electrical inspector certification are removed. The proposed rules also include the creation of continuing education requirements for the renewal of the license as a utility contractor. The proposal also removes dates and date-dependent requirements which are no longer relevant.

6. Summary of, and Comparison with, Existing or Proposed Federal Regulations.

The proposed rules address administrative issues unique to the department's rules. There are no existing or proposed federal regulations that address the activities to be regulated by the proposed rules.

7. Comparison with Rules in Adjacent States.

The proposed rules address administrative issues unique to the department's rules. There are no similar rules in the states of Illinois, Iowa, Michigan and Minnesota.

8. Summary of Factual Data and Analytical Methodologies.

The rules transitioning plumbing and sprinkler credential terms from 2 years to 4 years, were developed by assessing the Safety and Buildings Division resources, particularly staffing levels, with the current and projected workloads. The Division currently issues over 55,000 licenses, certifications and licenses. The other rule revisions were developed by evaluating their application or the licensing processes in order to either clarify or provide consistency across the licensing categories.

9. Analysis and Supporting Documents Used to Determine Effect on Small Business or in Preparation of Economic Impact Report.

The proposed rules should have a minimal effect on small business in that most of the credentials under chapter Comm 5 involve individuals and not businesses. The rules lengthening the plumbing and sprinkler credential terms to 4 years will result in the fees and the continuing educational obligations

Comm 5.003 (22) "HVAC equipment" means materials, piping, fittings, devices, appliances, apparatus, controls and control wiring used as part of or in connection with permanent heating, ventilating, or air conditioning installations in or exhausting systems serving buildings. HVAC equipment includes furnaces, ventilation ductwork, baseboard heaters, bathroom fans and kitchen hoods. HVAC equipment does not include residential bathroom fans and kitchen hoods, water heaters, process heating equipment, and space heaters such as masonry fireplaces and chimneys, factory-built fireplaces and venting systems, decorative gas fireplaces, water heaters and process heating equipment and woodburning stoves.

 - 1. Installing or servicing heating, ventilating or air conditioning equipment.
- 2. Installing or servicing refrigeration or air conditioning equipment that would release or may release ozone-depleting refrigerant.
- 3. Selling for reuse used ozone-depleting refrigerant from refrigeration or air conditioning equipment.
- (b) 1. A person, entity or business is not required to hold a registration as a registered HVAC contractor to service existing heating, ventilating, air conditioning, or refrigeration equipment within facilities or properties owned by the person, entity or business provided the air conditioning or refrigeration equipment does not involve ozone-depleting refrigerants.
- 2. A person, entity or business is not required to hold a registration as a registered HVAC contractor to install or service heating, ventilating, air conditioning, or refrigeration equipment within a dwelling owned by the person, entity or business and in which the person, entity or business resides or will reside provided the air conditioning or refrigeration equipment does not involve ozone-depleting refrigerants.
- 3. A person, entity or business is not required to hold a registration as a registered HVAC contractor for electrical or plumbing work associated with the installation or servicing of the HVAC equipment or systems.
