ADMINISTRATIVE RULES REPORT TO LEGISLATURE CLEARINGHOUSE RULE CR-08-108

By the Department of Health Services relating to ch. DHS 105, Provider Certification

Basis and Purpose of Proposed Rule

Section 49.45 (2) (a) 11., Stats., requires the Department to promulgate rules establishing criteria for certification of providers of medical assistance.

The Department proposes to amend ch. DHS 105 to allow federally recognized American Indian tribes or bands in Wisconsin to be certified by Wisconsin Medicaid as providers of personal care services. The proposed amendment would increase the number of providers available in Wisconsin to provide personal care services.

The Department believes that the proposed change is necessary in order to allow tribal government agencies to become personal care agencies, thereby providing tribal members access to culturally sensitive personal care providers in their own communities.

Responses to Legislative Council Rules Clearinghouse Recommendations

The Department accepted the comments made by the Legislative Council Rules Clearinghouse and made modifications where suggested.

Final Regulatory Flexibility Analysis

The proposed rule does not affect small business.

Changes to the Analysis or Fiscal Estimate

Analysis

As suggested by the Legislative Council Rules Clearinghouse, information was added to the rule's analysis about the communication exchanges between the Department and the Home Care Consumer Advisory Committee and the Home Care Advisory Committee.

Fiscal Estimate

As suggested by the Legislative Council Rules Clearinghouse, the Department made corrections in wording.

Public Hearing Summary

On January 2, 2009, the Department began accepting public comments on the proposed rule via the Wisconsin Administrative Rules web site. Two public hearings were held. One hearing was held in Wausau on February 3, 2009, while a second public hearing was held in Madison on February 4, 2009. The hearing record closed on February 18, 2009. Three people attended the public hearing in Madison, while there were no attendees at the Wausau public hearing. Three written comments were received, two of which were from the attendees at the public hearing.
