## REPORT ON Section Ins 1701(3).7.28(3)(c) and 17.28(6), Wis. Adm. Code, relating to annual Injured Patients and Families Compensation Fund fees, mediation panel fees, and provider classifications

Clearinghouse Rule No. 11-015 Submitted Under s. 227.19 (3), Stats.

(a) A detailed statement of basis for the proposed rule and how the rule advances relevant statutory goals or purposes:

Pursuant to s. 655.27 (3) (b) and s. 655.61, Wis. Stat., the commissioner of insurance, with approval of the injured patients and families compensation fund (fund) board of governors, is required to establish by administrative rule the annual fees for the fund and for the mediation system operated by the director of state courts. This rule establishes those fees for fiscal year 2011-2012.

(b) Summary of the public comments and the agency's responses to those comments:

A letter was received from Michael Richards on behalf of Gundersen Lutheran stating that while the assessment increase is justified, Gundersen Lutheran strongly encourages the fund to remain solvent, and abstain from any transfers outside of the fund's intended purpose. No response was necessary.
