#### **Basis and Purpose of Proposed Rule**

The intent of the proposed rulemaking is to repeal or amend rules that the department of health services ("the Department") has identified being in need of revision through the review process required under s. 227.29 (1) and (2), Stats..

## Department Response to Legislative Council Rules Clearinghouse Recommendations

The Department reviewed and accepted all of the recommendations from the Legislative Council Rules Clearinghouse. The proposed rule was revised as suggested by the Rules Clearinghouse, with the exception of sections 5.c, 5.f, and 5.g—all of which are being addressed through active or future rulemaking by the Department.

#### Final Regulatory Flexibility Analysis
