# REPORT TO LEGISLATURE

NR 10 and 45, Wis. Adm. Code

Board Order No. WM-18-22 Clearinghouse Rule No. 21-013

#### Basis and Purpose of the Proposed Rule

These rule changes were included in the 2023 Wildlife Management Spring Hearing rules package and questionnaire. The Spring Hearings are held annually to collect public input on conservation and environmental issues. This rule package will modify regulations for hunting, trapping, and target shooting found in Ch's. NR 10 Game and Hunting and 45 Miscellaneous Fur, Fish, Game and Outdoor Recreation These rules will:

- 1. Allow the use of F-shot while hunting migratory birds.
- 2. Simplify the rules for quartering deer, bear and elk.
- 3. Make youth antlerless permits valid on either public or private lands.
- 4. Increase the student registration fee for trapper education.
- 5. Allow individuals to aid disabled trappers in the field without holding specific harvest permits or authorizations for that animal.
- 6. Allow the issuance of an either-sex diseased deer replacement permit if a hunter harvests a diseased antlerless deer.
- 7. Allow landowners to shoot a bear in the act of killing, wounding, or biting a domestic animal without the need for written authorization from DNR.
- 8. Regulate shooting on department lands in Brown County.

The department received only one written comment during the official comment period. This individual didn't express support or opposition to any of the proposals but expressed concern that expanding the youth deer season and allowing youth antlerless permits to be valid on any property type would expand entitlements to youth which they don't feel increases independent youth enrollment.

### Modifications Made

The department solicited public input on one proposal that it ultimately elected not to include in this rule. The department also proposed expanding the October youth gun deer season from two to four days. After reviewing the public input and further discussing the rule proposals, the department chose to not move forward with the proposal at this time.

## Appearances at the Public Hearing

The Department held a virtual public hearing on the proposed permanent rule, WM-18-22 on May 17, 2023.. No members of the public attended the hearing.

## Changes to Rule Analysis and Fiscal Estimate

No changes were made to the rule analysis or fiscal estimate through the public comment process, as no public comments on either were received.

#### Response to Legislative Council Rules Clearinghouse Report

The Legislative Council Rules Clearinghouse submitted comments on May 9, 2023.

Changes to the proposed rule were made to address all recommendations by the Legislative Council Rules Clearinghouse.

#### Final Regulatory Flexibility Analysis

These rules, and the legislation which grants the department rule making authority, do not have a significant fiscal effect on the private sector or small businesses.
