ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD CREATING RULES

The Wisconsin Natural Resources Board adopts an order to create NR 19.30 relating to requiring criminal history checks on all volunteer all-terrain vehicle, boating, bowhunter, hunter education and snowmobile safety instructors

Analysis Prepared by Department of Natural Resources

Statutory authority: s. 227.11(2)(c), Stats.

Statutes interpreted: ss. 29.225(1), 23.33(4z), 30.74(1) and 350.108(1), Stats.

The Department is seeking this rule to require criminal history checks for all safety program volunteer instructors prior to certification to ensure no previous convictions of a significant nature exist. Instructors represent the Department when conducting safety training courses in communities throughout the state primarily to our youth 12 to under 16 years of age.

SECTION 1. NR 19.30 is created to read:

NR 19.30 CRIMINAL HISTORY CHECKS; VOLUNTEER SAFETY INSTRUCTORS. Whenever application is made to the department by a person interested in becoming certified to instruct as a volunteer all-terrain vehicle, boating, bowhunter, hunter education or snowmobile safety instructor, the bureau of law enforcement shall conduct a criminal history, character and background check on the applicant.

The foregoing rule was approved and adopted by the State of Wisconsin Natural Resources Board on March 27, 1996.

The rule shall take effect on the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.
