The Wisconsin Natural Resources Board proposes an order to repeal and recreate NR 10.01(1)(g)l.L. and 10.31(11) and create NR 10.01(1)(g)l.m. relating to migratory game bird hunting.

In this order:

Section 1. Early goose hunt subzone - retitles subzone for season date and bag purposes.

Section 3. <u>Early goose hunt subzone</u> - creates a second early September Canada goose subzone and identifies each subzone.
