

ORDER

An order of the Chiropractic Examining Board to amend Chir 9.03 (6) relating to approved chiropractic college preceptorship programs.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b) and 227.11 (2), Stats.

Statutes interpreted: s. 446.02 (9) (a), Stats.

In this proposed rule-making order the Chiropractic Examining Board amends s. Chir 9.03 (6) to permit colleges of chiropractic to report the identity of chiropractic preceptors on a schedule consistent with the academic calendar of the various colleges, rather than requiring reports at potentially unreasonable or uninformative intervals.

TEXT OF RULE

SECTION 1. Chir 9.03 (6) is amended to read:

Chir 9.03 (6) Provides a list to the board at least 45 days prior to every 3 months trimester or academic quarter of the chiropractors in Wisconsin who will be acting as preceptors in the program.

(END OF TEXT OF RULE)

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register pursuant to s. 227.22 (2) (intro.), Stats.


