ORDER

An order of the Barbering and Cosmetology Examining Board to create BC 3.03 (5) relating to booth rental arrangements.

Analysis prepared by the Department of Regulation and Licensing.

<u>ANALYSIS</u>

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 454.08 (4), Stats.

Statutes interpreted: s. 454.08 (4), Stats.

These proposed rules specify that a booth rental arrangement between a licensed establishment and an individual practitioner creates an obligation to license the rented premises as an independent business. These rules declare that the rental of a chair or booth by a practitioner from a licensed establishment creates a separate establishment, and a separate establishment license is required for the leased area. Those individuals who are renting individual chairs or booths will be required to obtain a manager's license or hire or retain a person with a manager's license, as well as obtain a separate license for the rented chair or booth as a separate establishment.

TEXT OF RULE

SECTION 1. BC 3.03 (5) is created to read:

BC 3.03 (5) The rental of a chair or booth from a licensed establishment creates a separate establishment, and a separate establishment license is required for the leased area.
