ORDER OF THE STATE CONSERVATION COMMISSION OF WISCONSIN ADOPTING, AMENDING AND REPEALING RULES

Pursuant to authority vested in the State Conservation Commission of Wisconsin by section 26.12, Wis. Stats., the State Conservation Commission of Wisconsin hereby repeals, amends and adopts rules as follows:
