ORDER ADOPTING FORMS

A form has been prepared whereon a riparian owner may make application to this Commission to improve recreational use of land adjacent to a lake by placing a layer of sand or similar material on the bed of said lake, as provided in section 30.02(1)(bs), Statutes, created by Chapter 523, Laws of 1957.

This form, as well as three others for the use of applicants submitting data required by the Statutes in connection with diversion of water for irrigation, the taking 'of materials from the beds of navigable lakes, and the construction of dams in navigable streams, were submitted to and approved by the Commission.

Like all material listed in Chapter PSC 8, Wisconsin Administrative Code, these forms can be obtained from the Commission, and should be added to the list of offical forms in said chapter to comply with section 227.013, Statutes.

Order

THE COMMISSION THEREFORE ORDERS:

- 1. That, under the procedure set forth in section 227.013, Statutes, section PSC 8.10 be and hereby is created and adopted to read:
 - PSC 8.10 Water powers; application forms. (1) Application for approval of the placing of

sand or other similar material on bed of lake. (section 30.02(1)(ba), Statutes)

- (2) Application for permit to divert water for irrigation under section 31.14, Statutes.
- (3) Application for contract to dredge materials from beds of navigable lakes listing those facts which are necessary before the Commission can determine that the application meets the requirements of section 31.02(5), Statutes.
- (4) Application for a permit to construct, operate, and maintain a dam in a navigable stream. (sections 31.05, 31.06, 31.09 and 31.12, Statutes)
- 2. That certified copies section PSC 8.10, Wisconsin Administrative Code, as herein created and adopted, be filed with the Secretary of State and the Revisor of Statutes, as required by section 227.023, Statutes.
