ORDER ADOPTING RULE

Section PSC 2.72, as created, was published in the November 1957 Notice Section of the Wisconsin Administrative Register. The Commission has received no petition for public hearing as provided for in section 227.02(1)(e), Wisconsin Statutes.

Now, therefore, pursuant to authority vested in the Public Service Commission of Wisconsin by chapter 196, Statutes, the Public Service Commission hereby orders:

1. That section PSC 2.72 of the Wisconsin Administrative Code be and the same is hereby adopted to read:

> PSC 2.72 <u>Sale of utility; reports;</u> assessments. In all cases where the purchase and sale of a complete utility property involves an abandonment of service and the dissolution of the selling utility, it shall / be a condition to the Commission's approval of the purchase of such utility property that the purchasing utility shall assume the following obligations of the selling utility and shall be responsible

(1) For all charges which are due or may become due from both the selling and the purchasing utility under the provisions of section 196.85(1), Wis. Stats., relating to the purchase and sale proceeding;

(2) For all charges which are due or may become due from the selling utility under the provisions of section 196.85(2)(a), Wis. Stats., relating to the current part-year public utility operations; (3) For the f

For the filing with the Commission (section 196.07, Wis. Stats.) of the required part-year final report covering the operations of the selling utility (except where written exemption is obtained from the Commission);

unless the selling utility complies with the particular provisions of sections 196.85 and 196.07, Wis. Stats., as set forth in this rule.

2. That section PSC 2.72 as herein adopted shall take effect on February 1, 1958, as provided in section 227.026(1), Statutes.

IT IS FURTHER ORDERED That certified copies of section PSC 2.72, Wisconsin Administrative Code, as herein created and adopted, be filed with the Revisor of Statutes and the Secretary of State as required by section 227.023, Statutes.
