ORDER ADOPTING AMENDED RULE

Section PSC 50.03(2), as amended, was published in the February 1958 Notice Section of the Wisconsin Administrative Register. The Commission has received no petition for public hearing as provided for in section 227.02(1)(e), Wisconsin Statutes.

Now, therefore, pursuant to authority vested in the Public Service Commission of Wisconsin by sections 194.02, 194.18, 194.36, and 194.43, Statutes, the Public Service Commission hereby orders:

1. That section PSC 50.03(2) of the Wisconsin Administrative Code be and the same is hereby amended and adopted to read:

PSC 50.03(2) None of the classes of traffic named in PSC 50.03 (1)(e) shall include articles packed in hermetically sealed containers, nor shall the empty return of vehicles, except vehicles used exclusively for the transportation of milk directly from the farms to the dairies, use the restricted highways when such vehicle exceeds 8,000 pounds in weight except where reasonably adequate alternate routes are not available.

2. That section PSC 50.03(2) as herein amended shall take effect on May 1, 1958, as provided in section 227.026(1), Statutes.

IT IS FURTHER ORDERED that certified copies of section PSC 50.03(2), Wisconsin Administrative Code, as herein

amended and adopted, be filed with the Revisor of Statutes and the Secretary of State as required by section 227.023, Statutes.
