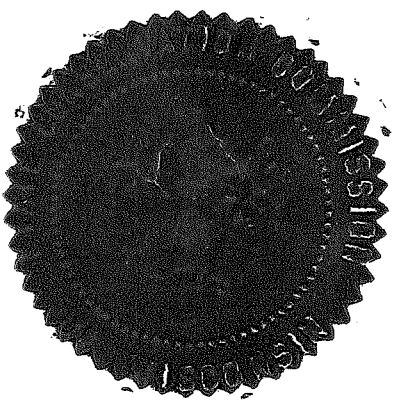

ORDER OF THE STATE CONSERVATION COMMISSION OF WISCONSIN
ADOPTING, AMENDING OR REPEALING RULES

Pursuant to the authority vested in the State Conservation Commission of Wisconsin by Section 29.174, Wis. Stats., the State Conservation Commission of Wisconsin hereby amends rules as follows:

Section WCD 20.06 (1) (b) of the Wisconsin Administrative Code is amended to read:

WCD 20.06 (1) (b) Trolling. It shall be unlawful for any person to take, capture, or kill fish or fish for fish of any variety at any time in the inland waters of this state from a motor-driven boat when the motor is running or from any boat in tow of a motor-driven boat when the motor is running or from any sailboat when in motion; or by means of shutting or drawing off water for that purpose. The restrictions contained in this paragraph do not apply to the Chetek Chain of lakes comprising Prairie, Mud, Pokegama, Chetek, Ten Mile and Moose Ear lakes in Barron county; Lake Eau Claire from Lake Eau Claire dam in Section 5, Township 26 North, Range 6 West, upstream to the Troubled Waters Bridge on highway "G" in Section 12, Township 26 North, Range 6 West, in that portion of Hay creek downstream from highway "MN" in Section 34, Township 26 North, Range 6 West, and that portion of Muskrat creek downstream from county highway "MN" in Sections 25 and 35, Township 26 North, Range 6 West, Eau Claire county; Shell lake in Washburn county; Lake Winnebago in Calumet, Fond du Lac and Winnebago counties; and Lake Wisconsin and the Wisconsin river beginning at the dam at Wisconsin Dells downstream to the dam at Prairie du Sac.

The amendments contained herein shall take effect May 1, 1958.
