## ORDER ADOPTING CREATED RULE

Chapter PSC 53, as created, was published in the December 1958 Notice Section of the Wisconsin Administrative Register. The Commission has received no petition for public hearing as provided for in section 227.02(1)(e), Statutes.

NOW, THEREFORE, Pursuant to authority vested in the Commission by Chapter 194, Statutes, the Public Service Commission orders:

1. That Chapter PSC 53 of the Wisconsin Administrative Code be and the same hereby is adopted to read:

#### CHAPTER PSC 53

REALIGNED OR BYPASS HIGHWAYS COMMON MOTOR CARRIERS

PSC 53.01 <u>Realigned or by pass highways as convenience routes.</u> All common motor carriers are hereby authorized to use as convenience routes any realigned or bypass highway bearing the same number as contained in their certificates, provided (1) That there is no cessation of service at points authorized to be served; and (2) That there are routes in their certificate permitting ingress and egress to said realigned or bypass highway.

2. That Chapter PSC 53 as herein adopted shall take effect on March 1, 1959, as provided in section 227.026(1), Statutes. IT IS FURTHER ORDERED That certified copies of Chapter PSC 53, Wisconsin Administrative Code, as herein created and adopted, be filed with the Revisor of Statutes and the Secretary of State.
