ORDER OF THE STATE BOARD OF HEALTH
ADOPTING AND REPEALING RULES

Pursuant to authority vested in the State Board of Health by Sections 140.05 (3) and 156.03, Wisconsin Statutes, the State Board of Health hereby repeals Section H 16.11, proof of academic training, Funeral Directors and Embalmers, and adopts Section H 16.11 (1) and (2), proof of academic training, Funeral Directors and Embalmers, as follows:

H 16.11 Proof of academic training.

(1) The following shall be accepted by the board as proof that the academic training requirements of section 156.095 (1) (a) of the Wisconsin statutes concerning registration as an apprentice funeral director or embalmer have been met: A signed statement by the registrar of any college or university recognized by the North Central Association of Colleges and Secondary Schools that the applicant has successfully completed one academic year of instruction in said college or university or has an equivalent education which will permit admission to such college or university with sophomore status.

(2) The following shall be accepted by the board as proof that the academic training requirements of section 156.045 (1) (d) of the Wisconsin statutes concerning requirements for a funeral director's or an embalmer's

license have been met: A signed statement by the registrar of any college or university recognized by the North Central Association of Colleges and Secondary Schools that the applicant has successfully completed two academic years of instruction in said college or university or has an equivalent education which will permit admission to such college or university with junior status.

The rule contained herein shall take effect on May 1, 1960 as provided in Section 227.026 (1), Wisconsin Statutes, subject to approval under the provisions of Section 14.225, Wisconsin Statutes.
