

Purcuent to the authority vested in the State Conservation Coesission of Misconmin by Sections 2).09 and 29.176, Wis. State., the State Conservation Commission of Misconsin hereby repeals and creates rules as follows:

Section WCD 26.01 (25) of the Wisconsin Akalmistrative Code is repealed.

Jection WCD 20.04 (h) (d) of the Wisconsin Administrative Code is created to ronds

SGD 20.0k (k) (d). It shall be unlawful for any person to take, catch or kill fish or fish for fish in, on or along any maters situated in Fovernor Rodge State Park in sections 2, 7, 10, 11, teamship 6 north, range 3 east, love County, except under the following conditions:

- l. Fishing in such waters is authorized only under permit, which may be secured at the checking station indicated by posted sign in the inscisto area.
- 2. Fishing in such waters shall be done only with hook and line or rod ani roci.
- 3. All permits are valid only for the date issued and shall be turned In at the checking station at the termination of each day's fishing activities by the fighterman.
- h. Fishing is prohibited from 10:00 p.m. to 0:00 a.m. of the following day.
- 5. All fish taken pursuant to this section shall be exhibited to the Conservation Cossission or its agents at the checking station in a whole and uncleaned condition for examination and recording. When combing station personnel are not on duty, each perdittee shall complete a creek census form provided and deposit the form at the crocking station.

The rules contained herein shall take effect on June 1, 1900.
