ORDER OF THE WISCONSIN REAL ESTATE BROKERS' BOARD

ADOPTING NEW RULE

Pursuant to authority vested in Wisconsin Real Estate Brokers' Board by Section 136.04 (1), Wisconsin Statutes, the Wisconsin Real Estate Brokers' Board hereby adopts the following rule:

R. E. B. 2.04 Renewal of License

7. New Licensees. Real estate salesmen and brokers; business opportunity salesmen and brokers and cemetery salesmen who receive their first new license after August 31 of any year shall be allowed to file a renewal application up to December 31 of the year in which they received said first new license without being required to pay a late filing fee. If said applicant files a renewal application after December 31 of said year, the late filing fee of \$10.00, plus the regular license fee must accompany said application.

The adoption of the above rule shall take effect on October 1, 1960, as provided in Sections 227.02 (1) (3) and 227.023 (1), Wisconsin Statutes.
