## ORDER OF THE WISCONSIN STATE BOARD OF PHARMACY ADDING RULES PHAR. 1.17 and PHAR. 1.18

Pursuant to the authority vested in the State Board of Pharmacy by section 151.01, Wis. Stats., the Board hereby adds to its rules as follows:

Sections Phar. 1.17 and Phar. 1.18 of the WISCONSIN ADMINISTRATIVE CODE are added as follows:

Phar. 1.17 No pharmacist, proprietor or manager of any pharmacy shall advertise in any manner, the availability of dangerous drugs by name.

Phar. 1.18 No pharmacist, proprietor or manager of any pharmacy shall advertise in any manner prices to be charged for prescription medication, either specifically or as a percentile of prevailing prices.

The rules contained herein shall take effect on February 1, 1961 as provided for in section 227.026.
