REPEALING RULES

Pursuant to authority vested in the State Board of Health by Sections 140.05 (3) and 159.03 (1), Wis. Stats., the State Board of Health hereby repeals rules relating to conducting cosmetology examinations as follows:

Subsection H 14.01 (3) of the WISCONSIN ADMINISTRATIVE CODE

is repealed.

(Namely: "(3) Each examiner shall examine all applicants in a part of the practical examination.")

NOTE: With the enactment of Chapter 399, Laws of 1961, compliance with Subsection H 14.01 (3) is not possible. Therefore, since the rule is procedural rather than substantive, a public hearing was not required (Sec. 227.02 (1) (a), Wis. Stats.).

The repeal contained herein shall take effect on December 1, 1961 as provided in Section 227.026 (1), Wis. Stats., subject to approval under the provisions of Section 14.225, Wis. Stats. Dated October 10, 1961
