**ORDER OF THE STATE BOARD OF HEALTH**

**ADOPTING AND AMENDING RULES**

Pursuant to authority vested in the State Board of Health by Sections 140.05 (3), 140.09 (4) and 141.03 (1) (b), Wis. Stats., the State Board of Health hereby amends and adopts rules relative to qualification requirements for non-medical health officers as follows:

*AP 7*  
*12-4-61*  
*Introducing paragraph*  
Section H 106.01<sup>1</sup> of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

H 106.01 Qualification requirements for non-medical health officers. To be eligible for appointment an applicant for non-medical health officer as required by sections 140.09 (4), 141.01 (3), 141.02 (2) and 141.03 (1) (b), Wis. Stats., shall meet the training and experience requirements of subsections (1), (2), or (3):

Subsection H 106.01 (3) of the WISCONSIN ADMINISTRATIVE CODE is created to read:

(3) Have completed within three years following appointment one year of academic training in a school of public health approved by the state health officer; have at least 10 years of

experience in public health practice approved by the state health officer, such experience having been acquired in the employ of an official federal, state or local public health agency; and pass an examination on public health administration given by the state board of health.

The rules and amendments contained herein shall take effect on January 1, 1962 as provided in Section 227.026 (1), Wis. Stats., subject to approval under the provisions of Section 14.225, Wis. Stats.
