ORDER OF THE STATE BOARD OF HEALTH ADOPTING, AMENDING AND REPEALING RULES

Pursuant to authority vested in the State Board of Health by Section 140.05 (3), Wis. Stats., the State Board of Health hereby repeals, amends and adopts rules relative to minimum standards for Wisconsin migrant labor camps as follows:

Subsection H 76.02 (1) of the WISCONSIN ADMINISTRATIVE CODE is repealed and recreated to read:

(1) The term migrant labor camp shall mean and include the site and all structures maintained as living quarters for 6 or more seasonal or migrant agricultural, industrial or construction workers and for their dependents by any person or for him or under his control and supervision.

Section H 76.15 of the WISCONSIN ADMINISTRATIVE CODE is repealed.

NOTE: With the enactment of Chapter 470, Laws of 1961, revisions of Chapter H 76 are necessary to bring the language of the existing rules into conformity with statutory provisions; therefore, no public hearing was held (Sec. 227.02 (1) (b), Wis. Stats.).

The rules, amendments and repeals contained herein shall take effect on January 1, 1962 as provided in Section 227.026 (1), Wis. Stats., subject to approval under the provisions of Section 14.225, Wis. State.
