ORDER OF THE GROUP INSURANCE BOARD
ADOPTING RULES

Pursuant to authority vested in the Group Insurance Board by section 66.919 (3) (a), Wis. Stats., and in conformity with section 227.02 (1) (b), Wis. Stats., the board hereby amends rules conforming to statutory changes made by Chapter 461, Laws of 1961, as follows:

Grp 2.23 (2) (a) is amended to read:

- (a) Such cessation shall not begin while any earnings are being received.

Grp 2.24 is amended to read:

The 20 year period specified in section 66.919 (4) (a) 2., (6) (c), (8) (cc) and (12), Wis. Stats., shall comprise only service for which compensation is paid by the state, except as provided by section 16.276 (1) (a), Wis. Stats., 1959, together with service specified in section 66.902 (3) (f), Wis. Stats., 1955.

Grp 10.01 is amended to read:


The group life insurance program provided by section 66.919 (15), Wis. Stats., shall be effective as of the ensuing January 1 if the resolution is filed with the director pursuant to section 66.919 (15) (c), Wis. Stats., prior to November 15. If filed between November 16 and December 31, it shall not be effective during the ensuing calendar year but shall be effective on January 1 of the following year.

Grp 10.23 (2) (a) is amended to read:

- (a) Such cessation shall not begin while any earnings are received.

The rules contained herein shall take effect on the first day of the month following their publication in the Wisconsin administrative register pursuant to section 227.026 (1) Wis. Stats.
